



Chumba Casino Sweeps Rules

NO PURCHASE OR PAYMENT NECESSARY TO PARTICIPATE. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE AN ELIGIBLE PARTICIPANT'S CHANCES OF WINNING.

Chumba Casino offers Eligible Participants the chance to play games for entertainment and enjoyment. Chumba Casino is offered through a Platform. Chumba Casino also gives away sweepstakes entries referred to as "Sweeps Coins" as set out in these Sweeps Rules. Sweeps Coins can be used to Participate in Promotional Play for a chance to win further Sweeps Coins which are redeemable for real prizes.

SWEEPS COINS ARE SUBJECT TO A MINIMUM PRIZE REDEMPTION THRESHOLD OF \$US100. AMOUNTS BELOW THE THRESHOLD ARE NOT ELIGIBLE FOR PRIZE REDEMPTION.

These Sweeps Rules are to be read in conjunction with the Chumba Casino Terms and Conditions ([T&Cs](#)). Terms which are defined in the T&Cs have the same meaning in these Sweeps Rules.

PLEASE NOTE THAT THESE SWEEPS RULES INCORPORATE CLAUSE 24 OF THE T&Cs, WHICH INCLUDES A PROVISION WAIVING THE RIGHT TO PURSUE ANY CLASS, GROUP OR REPRESENTATIVE CLAIM AND REQUIRING ELIGIBLE PARTICIPANTS TO PURSUE PAST, PENDING, AND FUTURE DISPUTES BETWEEN THE ELIGIBLE PARTICIPANT AND THE SPONSOR/PROMOTER THROUGH INDIVIDUAL ARBITRATION UNLESS THE ELIGIBLE PARTICIPANT OPTS OUT WITHIN THE SPECIFIED TIME FRAME. SEE CLAUSE 11 OF THESE SWEEPS RULES FOR MORE INFORMATION.

1. ELIGIBILITY TO PLAY CHUMBA CASINO

1.1. The following definitions apply to these Sweeps Rules:

- a. **Eligible Participant** means a person who is a legal resident of the Permitted Territories and is eligible to participate in Promotional Play as set out in clause 3 of the T&Cs;
- b. **Permitted Territories** means the United States (other than the states of Connecticut, Delaware, Idaho, Louisiana, Michigan, Mississippi, Montana, Nevada, New Jersey, New York, Tennessee, Washington, and West Virginia);
- c. **Postal Request Code** has the meaning set out in clause 3.4 of these Sweeps Rules;
- d. **Promotional Play** means Chumba Casino's sweepstakes promotions. Promotional Play is only open to Eligible Participants, who are at least twenty-one (21) years old or the age of majority in their jurisdiction (whichever occurs later) at the time of entry. PARTICIPATION IS VOID WHERE PROHIBITED BY LAW.

- 1.2. The Sweepstakes is subject to all applicable federal, state, provincial, territorial and local laws and regulations. It is the sole responsibility of an Eligible Participant to determine whether the Sweepstakes is legal and compliant with all regulations in the jurisdiction in which the Eligible Participant resides.
- 1.3. Participation constitutes the Eligible Participant's full and unconditional agreement to these Sweeps Rules and Sponsor's/Promoter's decisions, which are final and binding in all matters related to the Sweepstakes.



- 1.4. Winning a Prize is contingent upon fulfilling all requirements set out in these Sweeps Rules.
- 1.5. Employees of VGW Group, any of their respective affiliates, subsidiaries, holding companies, advertising agencies, or any other company or individual involved with the design, production, execution or distribution of the Sweepstakes and their immediate family (spouse, parents, siblings and children, whether the relationship is by birth, marriage or adoption) and household members (people who share the same residence at least 3 months of the year) are not eligible to participate.

2. SPONSOR/PROMOTER

The **Sponsor/Promoter** of the Sweepstakes is VGW Games Limited of Trident Park, Notabile Gardens No6 – Level 3 Central Business District Mdina Road, Zone 2 BIRKIRKARA, CBD2010, Malta.

3. HOW TO COLLECT SWEEPS COINS

- 3.1. To Participate, an Eligible Participant must have an active Customer Account. If an Eligible Participant does not have a Customer Account, the Eligible Participant can create one free of charge at <https://chumbacasino.com>). To enter the Sweepstakes, an Eligible Participant must access Chumba Casino at <https://chumbacasino.com> and sign in to their Customer Account.
- 3.2. Once they have accessed Chumba Casino, there are four potential ways for an Eligible Participant to collect Sweeps Coins:
 - (a) **Receive Sweeps Coins as a free bonus when purchasing Gold Coins.** Each Eligible Participant may receive Sweeps Coins as a bonus upon the purchase of specifically marked packs of Gold Coins. Gold Coins can be used for social game play in Chumba Casino. Gold Coins cannot be redeemed for prizes. The number of Sweeps Coins an Eligible Participant will receive as a bonus for each relevant Gold Coin purchase will be stated in the website purchase window. All purchases of Gold Coins are final and no refunds will be given.
 - (b) **Receive Sweeps Coins when entering Sweeps Coins no-cost giveaway contests on the Chumba Casino Facebook page.** The Sponsor/Promoter regularly holds Sweeps Coins no-cost giveaway contests which Eligible Participants can enter by following the instructions provided in the contest. These giveaways may require sharing the Facebook page posts or answering various game related questions to be eligible for entry. The amount of Sweeps Coins given away will be stated on the applicable Sweeps Coins no-cost contest post and will be added to each contest winner's Customer Account.
 - (c) **Receive Sweeps Coins by collecting the Daily Bonus.** At our election, Eligible Participants may be able to receive free Sweeps Coins on a daily basis by completing each of these steps (**Daily Bonus**):
 - i. sign into your Customer Account;
 - ii. click the "GET COINS" button at the top of the Chumba platform page;
 - iii. click the "Daily Bonus" button at the top of the "Get Coins" pop up; and
 - iv. click the "Claim" button at the bottom of the Daily Bonus tab.Eligible Participants enabled to collect the Daily Bonus may do so once per day (the daily clock resets every 24 hours).
 - (d) **Receive Sweeps Coins by sending a request by post.** Eligible Participants can receive free Sweeps Coins by obtaining a Postal Request Code and sending a standard post card or piece of white paper (**Request Card**) which must be 4" x 6", unfolded, blank and unlined and placed inside a stamped #10 envelope addressed in handwriting, to the following address and satisfying the requirements set out below:

Eligible Participants must:



- i. handwrite their return address on the front of the envelope and the words: "Sweepstakes Entries"; and
- ii. handwrite all of the following **on only one side of the Request Card** inserted inside the envelope:
 - A. in the top-left corner, one (and only one) unique one-time Postal Request Code (see clauses 3.4 and 3.5 of these Sweeps Rules for further information);
 - B. under the Postal Request Code, in the following order:
 - their full name as shown on their government issued identification;
 - the email address registered to their Chumba Casino account;
 - the return/residential address registered to their Chumba Casino account; and
 - the following statement:

"I wish to receive Sweeps Coins to participate in the sweepstakes promotions offered by Chumba Casino. By submitting this request, I hereby declare that I have read, understood and agree to be bound by Chumba Casino's Terms and Conditions and Sweeps Rules."
- iii. **FOR THE AVOIDANCE OF DOUBT, COMBINED REQUESTS SENT VIA PACKAGE OR PARCEL DO NOT MEET THE REQUIREMENTS SET OUT ABOVE AND ARE INVALID.**

3.3. There is a limit of one Request Card per outer envelope. For each Request Card an Eligible Participant submits in accordance with the above requirements, the Eligible Participant will receive 5 Sweeps Coins. The Sweeps Coins will be added to the Eligible Participant's Customer Account. **NOTE: An Eligible Participant must ensure that their handwriting is legible.** If the Eligible Participant's handwriting is not legible, the entry will be void and the Sweeps Coins will not be added to the Eligible Participant's Customer Account. The legibility of an Eligible Participant's handwriting will be determined by Sponsor/Promoter in its sole discretion. **THE REQUEST MUST ONLY BE MADE BY THE ELIGIBLE PARTICIPANT AND MUST BE POSTED FROM THE SAME STATE OR PROVINCE AS THE ELIGIBLE PARTICIPANT'S VERIFIED RESIDENTIAL ADDRESS.** Requests made by any other individual or any entity (including but not limited to commercial sweepstakes subscription notification and/or entering services) or posted from a state or province different to the Eligible Participant's verified residential address will be declared invalid and Sweeps Coins will not be added to the Eligible Participant's Customer Account. Tampering with the entry process or the operation of the Sweepstakes, including but not limited to the use of any device or software to automate the Sweeps Coins request/entry process or to unfairly assist the Eligible Participant with meeting the handwriting requirement, is prohibited and any requests/entries deemed by Sponsor/Promoter, in its sole discretion, to have been submitted in this manner will be void. Where there is an issue or fault with an envelope used by an Eligible Participant to request free Sweeps Coins, such that it does, or is reasonably likely to, cause damage to, or otherwise adversely affect, equipment used or procedures implemented to process mailed in requests (for example, handmade envelopes that are not suitable for machine processing due to poor quality or non-standard adhesive or paper), such entry will be void. In the event a dispute regarding the identity of the individual who actually submitted a request or whether a request satisfies the requirements set out above cannot be resolved to Sponsor/Promoter's satisfaction, the affected request/entry will be deemed ineligible.

3.4. **A Postal Request Code** is a unique combination of 12 digits that Eligible Participants can obtain by following the steps outlined in clause 3.5 of these Sweeps Rules. A Postal Request Code is unique, can only be used once and expires 30 days after it is displayed. **The purpose of a Postal Request Code is to assist with the efficient and effective processing of an Eligible Participant's Request Card.** Request Cards containing an expired Postal Request Code at the time of processing will be void. **A POSTAL REQUEST CODE CAN ONLY BE USED BY THE ELIGIBLE PARTICIPANT WHOSE CUSTOMER ACCOUNT WAS USED TO GENERATE THAT POSTAL REQUEST CODE.** Any Eligible Participant suspected by Sponsor/Promoter to have directly or indirectly provided a Postal Request Code to another person may, in the sole discretion of Sponsor/Promoter, be disqualified and lose their eligibility to Participate in the Sweepstakes.

3.5. A Postal Request Code can be obtained by following each of these steps:



- (a) sign into the Eligible Participant's Customer Account;
- (b) click on the "Postal Request Code" link in the Platform lobby;
- (c) click on the "Postal Request Codes" button and follow the prompts.

The Postal Request Code is then displayed for a period of time to enable an Eligible Participant to record it on their Request Card.

- 3.6. The amount of Sweeps Coins an Eligible Participant has will be displayed in their Customer Account on the Platform. The amount of Sweeps Coins to be allocated to Eligible Participants can be changed at any time by the Sponsor/Promoter in its sole discretion.
- 3.7. Sponsor/Promoter is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected Sweeps Coins requests or allocations.
- 3.8. In the event of a dispute as to any registration of a Customer Account, the authorized account holder of the email address used to register the Customer Account will be deemed to be the Eligible Participant. The "authorized account holder" is the natural person assigned the email address by an internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.
- 3.9. Use of any automated or other system(s) to Participate, to acquire Sweeps Coins or play the games is prohibited and will result in disqualification and loss of eligibility to Participate in the games.
- 3.10. Sweeps Coins are only valid for sixty (60) days from the date an Eligible Participant last logged on to their Customer Account and will then automatically expire.
- 3.11. Sweeps Coins may also be forfeited if an Eligible Participant's Customer Account is closed for any reason, or at the Sponsor/Promoter's discretion.

4. USING SWEEPS COINS TO PLAY GAMES

- 4.1. Eligible Participants with Sweeps Coins can use those Sweeps Coins to play games within Chumba Casino for a chance to win additional Sweeps Coins. Sweeps Coins won through game play can be redeemed for real prizes.
- 4.2. Within Chumba Casino there are different games. The amount of Sweeps Coins required to play each game will be detailed next to the game. An Eligible Participant may be able to increase the amount of Sweeps Coins they play the game with so they can increase their potential winning eligibility.
- 4.3. Only games played with Sweeps Coins provide the opportunity to redeem winnings for real prizes. The prize that can be won while playing a game will be shown in Chumba Casino by clicking the "Win Table" or "Pay Table" button, denominated as "Sweeps Coins".
- 4.4. Each Sweeps Coin that has been won through game play (rather than collected using one of the methods described in clause 3 of these Sweeps Rules) can be redeemed for a prize with value being equivalent to US\$1.
- 4.5. Sponsor's/Promoter's decisions as to the administration and operation of the Sweepstakes, the game and the amount of winnings are final and binding.
- 4.6. Unless Sponsor/Promoter requires otherwise, any Sweeps Coins allocated to an Eligible Participant are required to be played once before they are eligible to be redeemed for prizes. Sponsor/Promoter may, in its sole discretion, require that any Sweeps Coins allocated to an Eligible Participant must be played a greater number of times (not exceeding 20) in any combination of Sweeps Coins games before they are eligible to be redeemed for prizes.
- 4.7. Sponsor/Promoter reserves the right to change the prize win rates and odds of any of the Sweepstakes at any time. An Eligible Participant can see the actual and any amended details by clicking on the "Win Table" or "Pay Table" button. It is an Eligible Participant's responsibility to check the prize win rate on each occasion before they Participate.



5. VERIFICATION AND CONFIRMATION OF POTENTIAL WINNERS

- 5.1. **POTENTIAL SWEEPSTAKES WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR/PROMOTER (IN ANY MANNER IT MAY CHOOSE) AND THE DECISIONS OF SPONSOR/PROMOTER ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. AN ELIGIBLE PARTICIPANT IS NOT A WINNER OF ANY PRIZE, EVEN IF THE ONLINE SCREEN INDICATES THEY ARE, UNLESS AND UNTIL THE ELIGIBLE PARTICIPANT'S ELIGIBILITY AND THE POTENTIAL WINNING PLAY HAS BEEN VERIFIED AND THE ELIGIBLE PARTICIPANT HAS FULLY COMPLIED WITH THESE SWEEPS RULES AND BEEN NOTIFIED THAT VERIFICATION IS COMPLETE. SPONSOR/PROMOTER WILL NOT ACCEPT SCREEN SHOTS OR OTHER PURPORTED EVIDENCE OF WINNING IN LIEU OF ITS VALIDATION PROCESS.**
- 5.2. Potential prize winners must comply with these Sweeps Rules and winning is contingent upon fulfilling all requirements.
- 5.3. A potential prize winner may be required to sign and return to Sponsor/Promoter, an affidavit/declaration of eligibility, and liability/publicity release (except where prohibited) in order to claim his/her prize (if applicable).
- 5.4. If a potential winner cannot be contacted, fails to properly execute and return the affidavit/declaration of eligibility and liability/publicity release within the required time period (if applicable), fails to comply with these Sweeps Rules, or if the prize or prize notification is returned as undeliverable, that potential winner forfeits the prize.
- 5.5. In the event that a potential winner of a Sweepstakes prize is disqualified for any reason, Sponsor/Promoter may, in its sole discretion, reseed the prize back into the Sweepstakes.

6. PRIZES

- 6.1. An Eligible Participant's Sweeps Coins balance is shown in the Eligible Participant's Customer Account.
- 6.2. Prizes are not awarded until redeemed. An Eligible Participant has no rights to Sweeps Coins that have not been redeemed.
- 6.3. Where an Eligible Participant has chosen to redeem prizes for cash, the payment will be made in USD to the financial account or online wallet from which the Eligible Participant purchased Gold Coins, or if this is not technically possible, then to an alternative bank account the Eligible Participant nominates. Sponsor/Promoter reserves the right to require the use of the same payment method for redemption of prizes as was used to purchase Gold Coins, or a specific payment method at Sponsor/Promoter's discretion.
- 6.4. Where an Eligible Participant has chosen to redeem prizes for gift cards, the gift cards will be allocated to the email address that the Eligible Participant has registered against their Customer Account.
- 6.5. Sponsor/Promoter will only process a prize redemption if the redeemed value of the prize is US\$100 or more (i.e. a minimum of 100 eligible Sweeps Coins). Consequently, an Eligible Participant's Customer Account must have a balance of at least 100 Sweeps Coins before requesting a prize redemption.
- 6.6. TO BE ELIGIBLE FOR A SWEEPS COINS PRIZE OR A SWEEPS COINS PRIZE REDEMPTION:
 - (a) A PARTICIPANT MUST BE AN ELIGIBLE PARTICIPANT; AND
 - (b) THE ELIGIBLE PARTICIPANT'S DETAILS MUST MATCH THOSE OF THE ELIGIBLE PARTICIPANT'S CUSTOMER ACCOUNT.
- 6.7. In Florida, the maximum redemption value of a Sweeps Coins prize won on any one spin or play, via an Eligible Participant's participation in the Sweepstakes is US\$5,000. Any prize valued in excess of US\$5,000 will be reduced to a maximum value of US\$5,000.
- 6.8. Sponsor/Promoter reserves the right, in its sole discretion, to limit an Eligible Participant's redemption of Sweeps Coins to US\$10,000 per day or any other amount over any time that Sponsor/Promoter considers necessary to satisfy its regulatory obligations or the requirements of its partners and suppliers. No more than the stated number of prizes will be awarded.



- 6.9. Sponsor/Promoter is not responsible for any taxes or fees associated with a prize redemption. Eligible Participants are responsible for all applicable taxes and fees associated with prize receipt and/or redemption.
- 6.10. Sponsor/Promoter is not responsible for any foreign exchange transaction fees, charges or related costs that may be incurred as a result of, or in relation to, a prize redemption, including but not limited to any losses or additional costs arising from foreign exchange fluctuations.
- 6.11. Sweeps Coins are not transferable and no substitution will be made except as provided herein at the Sponsor's/Promoter's sole discretion. Sponsor/Promoter reserves the right to substitute the listed prize of equal or greater value for any reason owing to circumstances outside Sponsor's/Promoter's reasonable control.
- 6.12. Prize winners will be notified by private message or email.

7. ENTRY CONDITIONS AND RELEASE

- 7.1. By Participating, each Eligible Participant agrees to:

- (a) comply with and be bound by:
 - i. the T&Cs;
 - ii. these Sweeps Rules; and
 - iii. the decisions of the Sponsor/Promoter which are binding and final;
- (b) release and hold harmless the Sponsor/Promoter and its parent, subsidiary, and affiliated companies, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the **Released Parties**) from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to an Eligible Participant's entry, creation of an entry or submission of an entry, participation in the Sweepstakes, acceptance or use or misuse of prizes (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and
- (c) indemnify, defend and hold harmless the Sponsor/Promoter from and against any and all claims, expenses, and liabilities (including reasonable attorneys/legal fees) arising out of or relating to an Eligible Participant's Participation in the Sweepstakes and/or an Eligible Participant's acceptance, use or misuse of prizes.

8. PUBLICITY

Except where prohibited, Participation in the Sweepstakes constitutes each Eligible Participant's consent to Sponsor's/Promoter's and its agents' use of Eligible Participant's name, likeness, photograph, voice, opinions and/or hometown and state/province/territory for promotional purposes in any media, worldwide, without further payment, notice or consideration.

9. GENERAL CONDITIONS

- 9.1. Sponsor/Promoter reserves the right to cancel, suspend and/or modify the Sweepstakes or these Sweeps Rules, or any part of the Sweepstakes or these Sweeps Rules, with immediate effect owing to circumstances outside its reasonable control and only where circumstances make it unavoidable if any fraud, technical failures or any other factor beyond Sponsor's/Promoter's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor/Promoter in its sole discretion.



- 9.2. Sponsor/Promoter reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Sweeps Rules or any other promotion or in an unsportsmanlike or disruptive manner.
- 9.3. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law and, should such an attempt be made, Sponsor/Promoter reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's/Promoter's failure to enforce any term of these Sweeps Rules shall not constitute a waiver of that provision.
- 9.4. In all other cases, the Sponsor/Promoter reserves the right to cancel, suspend and/or modify the Sweepstakes. Any notice regarding cancellation, suspension and/or modification will be posted on Chumba Casino at <https://chumbacasino.com>.
- 9.5. Whenever the Sponsor/Promoter amends these Sweeps Rules in a way that would limit an Eligible Participant's current rights or which may be to the Eligible Participant's detriment, the Sponsor/Promoter will notify the Eligible Participant upon the Eligible Participant's next visit to the Platform and the Eligible Participant will be required to re-confirm their acceptance prior to Participating in any Promotional Play. If the Eligible Participant does not agree to the amended Sweeps Rules, the Eligible Participant may not Participate in any Promotional Play.

10. LIMITATIONS OF LIABILITY

- 10.1. Insofar as permitted by law in the respective territories, the Released Parties (as defined above) are not responsible for:
 - (a) any incorrect or inaccurate information, whether caused by an Eligible Participant, printing error or by any of the equipment or programming associated with or utilized in the Sweepstakes;
 - (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software;
 - (c) unauthorized human intervention in any part of the entry process or the Sweepstakes;
 - (d) technical or human error which may occur in the administration or operation of the Sweepstakes; or
 - (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the Eligible Participant's Participation in the Sweepstakes or receipt or use or misuse of any prize.
- 10.2. If for any reason an Eligible Participant's Sweeps Coins or winning play is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, the Eligible Participant's sole remedy is replacement by Sponsor/Promotor of an equivalent amount of Sweeps Coins.

11. DISPUTES

Clause 24 of the [T&Cs](#) (Dispute Resolution and Agreement to Arbitrate on an Individual Basis) is incorporated herein by reference with the same force and effect as though fully set forth herein. By agreeing to these Sweeps Rules, the Eligible Participant agrees to be bound by the dispute resolution and arbitration provisions contained in clause 24 of the T&Cs.

12. OTHER

- 12.1. Under no circumstances will any Eligible Participant be permitted to obtain awards for, and Eligible Participant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than Eligible Participant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and Eligible Participant further waives all rights to have damages multiplied or increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO THE ELIGIBLE PARTICIPANT.**



- 12.2. All issues and questions concerning the construction, validity, interpretation and enforceability of these Sweeps Rules, or the rights and obligations of the Eligible Participant and Sponsor/Promoter in connection with the Sweepstakes, are governed by, and construed in accordance with, the laws of the Province of Ontario and the laws of Canada applicable in Ontario, without giving effect to any choice of law or conflict of law rules (whether of the Province of Ontario or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the Province of Ontario.
- 12.3. To ensure fairness and the integrity of the promotion to all Eligible Participants, the Sponsor/Promoter will respond to questions to Customer Support via this [form](#) and may post updates/communications on its Facebook page.
- 12.4.
